

Why Establish a Trust?



A trust helps to ensure the money received from settlements, and revenues generated from economic development, is used as intended by the Nation –preserving resources for current and future generations.



Trustee Duties



Engage an investment manager

Follow trust agreement and policies

Approve income and capital distributions

Arrange annual audit

Prepare annual report

Annual meeting with membership

Implements policy or procedures




Corporate Trustee



- Ensures Compliance with Trust Agreement
- Guarantees safekeeping of Trust Monies
- Oversees investment and administration of the Trust property
- Confirms all Trust requirements are met before releasing funds
- Account to Temagami First Nation

Typical Timeline





Per-Capita Distributions – Adult



- One-time adult PCD's are commonly distributed upon settlement – can also use bridge financing
- Most efficiently administered by the finance office of the Nation, or by Royal Trust directly
- Importance of working together to get ready for the flow of funds – financial literacy programs, bank account openings, connect with local banks, set expectations

Per-Capita Distributions – Minors

Some considerations:

- Royal Trust
- First Nation (via Bank Account)

Interest Calculation

- Inflation (CPI)
- Flat rate
- Earned income

Requirements to Receive PCD

- Upon turning 18
- Completion of Financial Literacy Course

Paying Deceased Minors

- Pay
 Guardian/Executor
 directly
- Pay to Estate
- Pay as per BCR

Royal Trust's all-inclusive annual Corporate Trustee fees include fiduciary responsibilities, discretionary decision making, relationship management, investment policy development and oversight, custodial services, trust administration, and record keeping and travel.

Thereafter	0.025%


